

# Kiwanis Club of Scotts Valley

## Stage Contract



**Please note that all items are available ONLY to charitable and community service organizations.**

The Kiwanis Club of Scotts Valley provides a mobile stage for rent. The stage is 24' wide, 12' deep and 12' high. The platform is 40" above the ground. The stage can be towed and set up in most venues, with a two-person crew. There is a built-in entrance stair at the right rear. If more entrances and exits are required they should be rented separately.

There is a \$1,000 surety and damage deposit that must be provided upon booking of the stage. Deposit checks will be immediately negotiated. Cancellations and alterations in duration of rental must be made ten days prior to delivery. Cancellations prior to that date will receive 100% of the deposit returned. After that date the deposit will be retained.

The renter is responsible for the security of the stage during the entire period it is on-site. The deposit will be returned in full upon inspection of the equipment for loss or damage after the event. If there is damage or loss of equipment, the repair will be made and paid with the deposit. The remainder of funds in the deposit account will be refunded to the renter, but if the cost of the damage is greater than \$1000 the renter is responsible for the reasonable cost of all repairs.

The rental fee is \$1,000 for a one-weekend event. The stage is available for venues in the Monterey Bay area, but there is a transportation and set-up charge of \$250 outside the Scotts Valley City limits. Special quotes will be made for events that occur during weekdays or last longer than a weekend. All anticipated rent is required to be paid prior to set up of the stage. Rent payment may be made by cash or check.

Kiwanis agrees to deliver the stage within two hours of the time agreed upon at booking, but not before Friday at 3PM and to be on site within two hours of the pre-agreed upon pickup time, but not after Sunday at 6PM.

Renter agrees to indemnify and hold harmless the Kiwanis Club of Scotts Valley, Kiwanis District 43, Cal-Nev-Ha Division, Kiwanis International and all its members from any and all injury and damage claims resulting from the use of the stage.

Renter agrees to all terms and conditions, stated herein and accepts responsibility for return of the stage in good condition. Signatory is either a duly recognized agent of the renting organization with authority to obligate renting organization for care of the stage, or personally accepts such responsibility.
